# **1** APPLICATIONS FOR MEMBERSHIP

This regulation relates to section 5.3 of the Constitution:

Section 5.3c of the Constitution requires the Executive Committee to determine whether an application for membership should be accepted. In making this determination, the Club Secretary shall place a notice of the application on the Club Notice Board and invite any member to object to the application being accepted.

Additionally, in the close season, this notice shall be emailed to all members for whom the club holds an email address. Any objection should set out the reason for such objection and be received by the Club Secretary within fourteen days of the notice being placed on the Club Notice Board.

The Executive shall then determine whether the application should be accepted in accordance with Section 5.3 c of the Constitution, taking account of any objection received.

### 2 REDUCTION OF FEE FOR LATE MEMBSRSHIP

This Regulation relates to section 7.3 of the Constitution:

Section 7.3 of the Constitution allows for the reduction of the first annual subscription of any Full Member or Junior Member accepted to membership after the commencement of the playing season. Members who join late in the season will be charged a reduced fee, determined by the Treasurer.

At the discretion of the Executive Committee a reduced fee may also be allowed to members who are unable to play for part of the season because of illness or the like.

#### **3 DRESS CODE**

#### 3.1 Inter-Club Matches

For all Inter-Club matches or Representative games all players will wear club shirts and grey or white trousers/shorts or skirts as stipulated on the team sheet displayed on the Club team selection notice board. Shorts if worn shall be tailored or Bowls England approved. Pullovers, cardigans and rainwear should be predominately white, or Club colours.

On the green all players will wear Bowls England approved shoes, i.e. Players, umpires and markers must wear flat-soled ('heel-less') footwear when they play on the green or act as umpires or markers.

#### 3.2 Roll Ups

The dress code for practice roll ups will be smart casual clothes, although a white shirt or polo type bowls shirt with collar is preferred. Shorts are allowed but must be tailored or Bowls England approved. Shoes must be Bowls England approved

T-shirts or tops without collars or sleeves will not be permitted.

#### **3.3** Internal Club Competitions and Drives

Players in internal Club competitions and drives will wear Club or white tops with grey trousers/shorts or skirts all as stipulated above apart from Club finals when Club shirts and white trousers/shorts or skirts shall be worn.

## **4** USE OF THE GREEN BY NON-MEMBERS

Permission for members of the public to hire a rink will be at the discretion of a playing member who is present at the time and is prepared to oversee the use of the green for the whole session, take charge of payment for the rink fee and issue a receipt. Hire is also dependent on whether a rink is available and that league or Surrey games are not being played at the same time.

A fee of  $\pounds 5.00$  per person should be paid for a two-hour session, to include necessary equipment. Appropriate footwear must be worn.

Guests of full playing members may also use the green on the same conditions as the general public on a maximum of three occasions during the season.. The member will be expected to play with their guests and oversee the use of the green for the whole period the rink is in use.

Guests or members of the public will not be allowed to join in with any organised roll-ups or use club facilities, other than toilets and visitors changing rooms if required.

Non- playing members and social members are not eligible to use the green.

Recent full members who have reverted to non- playing membership because of illness may be allowed to use the green, at the discretion of the Executive, if they are considering becoming full members again

## **5 DESIGNATED SMOKING AREA**

Smoking, including the use of electronic smoking devices, is not allowed in the clubhouse on the green or the surrounding areas.

A designated smoking area has been identified between the gate entrance to the green and the fox fence.
